8. SUMMARY OF GUIDELINES FOR THE PRACTICE OF THE ENGINEERING PROFESSION IN QUEBEC

Laws and regulations govern the practice of engineering in Quebec, including:

- The [Code of Ethics of Engineers](#)
- The [Professional Code](#)
- The [Engineers Act](#)
- The [Civil code of Quebec](#)
- Le [Règlement sur l'assurance de la responsabilité professionnelle des ingénieurs](#)
- Le [Règlement sur la formation continue obligatoire des ingénieurs](#)

Professional Code, section 59.2

59.2. No professional may engage in an act derogatory to the honour or dignity of his profession or to the discipline of the members of the order, or practise a profession, carry on a trade, enterprise or business, or hold an office or function that is inconsistent with the honour, dignity or practice of his profession.

Some important sections of the Code of ethics of engineers

2.01. In all aspects of his work, the engineer must respect his obligations towards man and consider the consequences of the performance of his work on the environment and on the life, health and property of every person.

2.03. Whenever an engineer considers that certain works are a danger to public safety, he must notify the Ordre des ingénieurs du Québec or the persons responsible for such work.

2.04. The engineer shall express his opinion on matters dealing with engineering only if such opinion is based on sufficient knowledge and honest convictions.

3.01.01. Before accepting a mandate, an engineer must bear in mind the extent of his proficiency and aptitudes and also the means at his disposal to carry out the mandate.

3.02.01. An engineer must fulfill his professional obligations with integrity.

3.02.04. An engineer must refrain from expressing or giving contradictory or incomplete opinions or advice, and from presenting or using plans, specifications and other documents which he knows to be ambiguous or which are not sufficiently explicit.

3.02.05. An engineer must inform his client as early as possible of any error that might cause the latter prejudice and which cannot be easily rectified, made by him in the carrying out of his mandate.

3.02.07. Where an engineer is responsible for the technical quality of engineering work, and his opinion is ignored, the engineer must clearly indicate to his client, in writing, the consequences which may result therefrom.

3.03.01. An engineer must show reasonable availability and diligence in the practice of his profession.

3.05.03. An engineer must always safeguard his professional independence and avoid any situation which would put him in conflict of interest.

3.05.04. As soon as he ascertains that he is in a situation of conflict of interest, the engineer must notify his client thereof and ask his authorization to continue his mandate.

Mandatory Continuing Education for Engineers

Every holder of a professional engineer's permit must meet the requirements of the regulation on mandatory continuing education for engineers. You will find all the required information [here](#).

IMPORTANT: Although this section contains a number of articles relevant to the practice of the profession, it is the responsibility of the holder of a permit to know and comply with all laws and regulations applicable to the engineering profession.

- I declare that I have professional liability insurance coverage, in accordance with the Professional Engineers Professional Liability Insurance Regulation, for the reserved professional activities that I will be performing under this application for a temporary permit.
- In accordance with section 59.3 of the Professional Code, I agree to inform the Ordre des ingénieurs du Québec of any judicial or disciplinary decision concerning me that may arise during the year, within ten (10) days of being informed.
- I agree to inform the OIQ within ten (10) days of any change in the scope of my mandate for the project. I understand that approval from the OIQ is required before I can perform any activities related to the revised mandate.

WHAT IS A TEMPORARY PERMIT FOR A SPECIFIC PROJECT?

THE ENGINEERING PROFESSION IN QUEBEC

Several laws and regulations govern the practice of professions in Quebec. Thus, the Professional Code, the Engineers Act, the *Charte de la langue Française* and several other regulations govern the professional activities of engineers.

Only those who hold an engineering permit and are registered with the Ordre des ingénieurs du Québec may practice engineering or use the title of engineer in Quebec.

To obtain the title of engineer in Quebec, each applicant must satisfy **these 3 conditions**:

1. Demonstrate his or her engineering knowledge and professional experience
2. Demonstrate knowledge of the laws and regulations governing the engineering profession in Quebec
3. Demonstrate an appropriate knowledge of French to practice the profession.

THE TEMPORARY PERMIT

A temporary permit is granted for a limited period and for a specific project to a person who will carry out professional activities in Quebec.

Temporary permits are only granted to individuals. Even for a temporary permit, the applicant must meet the 3 main conditions mentioned above.

A temporary permit is issued for a period of one year from the date of issue of the permit.

It generally takes 10 to 12 weeks for a permit application to be approved, starting from the date of reception of all documents. This delay may vary depending on the Admissions Committee's meeting schedule.

ANNEX 2 TYPES OF ELIGIBLE PROFILES

Four profiles are eligible for a temporary permit under section 41 of the Professional Code:

- Professional engineers who are members of another professional association;
- Holders of an engineering degree that is covered by an agreement (ARM) or the Washington Accord;
- Holders of an engineering degree that is not covered by an agreement (ARM) or the Washington Accord;
- Holders of a legal authorization to practice engineering issued outside of Quebec.

Engineering degree covered by a Mutual Recognition Agreement or ARM between France and Quebec

Holders of a diploma issued at the end of a training program accredited by the Commission des Titres d'Ingénieur (CTI) and leading to the title "ingénieur diplômé" in France may obtain a temporary permit.

To ensure that your engineering degree is part of this agreement, please consult the list available on the [OIQ's website](#).

If the degree or specialty is not listed, the degree may be considered "without agreement".

IMPORTANT: Some CTI-accredited training programs are not covered by the agreement and do not qualify for a temporary permit. These include, for example, training in agronomy, land surveying, forestry engineering or business engineering. The same is true for specialized training. It should also be noted that this agreement (ARM) does not apply to qualifications issued following the validation of prior learning or those issued outside France or following a program of study outside of France.

The list of accredited programs can be consulted on the CTI website.

Frequently asked questions:

Question: The engineering degree and specialty listed in the agreement (ARM) are different from those on my degree, but the training is the same. Can I get a temporary permit?

Answer: A decree or communication from the CTI confirming this information is required if the academic training is the same. The educational institution may also confirm this information. In this case, you are eligible for a temporary permit.

Engineering degree covered by the Washington Accord

To ensure that your engineering degree is part of this agreement, please verify that your country and your degree are covered by the [Washington Accord](#).

Engineering degree not covered by an agreement under the Washington Accord or a mutual agreement

If you are not currently registered as a professional engineer with an association in Canada and your engineering degree is not covered by a mutual recognition agreement, you may be required to write a technical exam or attend a technical interview, depending on the OIQ's requirement.

Engineering in Quebec: a profession governed by the *Charte de la langue française*

In Quebec, professional orders can only issue permits to people who have an appropriate knowledge of French, the official language,
to practice their profession (section 35 of the *Charte de la langue française*).

If a person completed their studies in Quebec, they only need to provide a copy of their high school certificate issued by the Ministry of Education.

In Quebec, professional orders may only issue permits to persons who have sufficient or appropriate knowledge of French, the official language of this province.

Under section 35 of the *Charte de la langue française*, a person is deemed to have this knowledge if:

- they have received, on a full-time basis, at least three years of high school or post-secondary education given in French;

or if

- they have passed the examinations in French as a first language in the fourth or fifth year of high school (in Quebec);

Or if

- they have obtained a high school diploma in Quebec as of the 1985-1986 school year. In that case, the person only needs to provide a copy of their high school certificate issued by the Ministère de l'Éducation.

Do you have knowledge of the French language which is sufficient to practice the profession:

You answered "Yes" and justified your knowledge of the French language	The permit will be issued under section 41 of the Professional Code. It may be renewed until the end of the applicant's assignment.
You answered "No"	The permit will be issued under section 41 of the Professional Code and section 37 of the <i>Charte de la langue française</i> . It may be renewed up to three times by the Ordre des ingénieurs du Québec, with the authorization of the Office québécois de la langue française .

Renewal:

The permit will be issued under section 41 of the Professional Code. It may be renewed until the end of the applicant's assignment.

For those who have not demonstrated appropriate knowledge of French:

The permit may be renewed a maximum of three times upon authorization from the Office québécois de la langue française.

If the applicant's assignment will last longer than 48 months, please notify the Ordre des ingénieurs du Québec at the outset.

Frequently asked questions:

Question: I am French or from another French-speaking country, do I have to prove my knowledge of the French language?

Answer: Yes, all applicants for an engineering permit must meet this government requirement.

Question: If I studied in French outside of Quebec, how do I prove that I have adequate knowledge of French?

Answer: You must provide an official copy of your transcripts of at least 3 years of full-time study in French or an attestation issued by the Office québécois de la langue française indicating that you have passed the French language tests.

Question: What is the Office québécois de la langue française or OQLF?

Answer: It is an organization designated by the Government of Quebec whose mission is to ensure compliance with the *Charte de la langue française*. For more information, visit their [website](#).

Professional liability insurance: what is private practice?

The Ordre des ingénieurs du Québec must be informed of the type of practice of each candidate.

Private Practice:

In accordance with section 3 of the *Règlement sur l'assurance de la responsabilité professionnelle des ingénieurs*, a professional engineer in private practice, other than one referred to in sections 5 or 6 of that Regulation, must subscribe to the group professional liability insurance plan entered by the OIQ, which provides coverage against liability that the engineer may incur because of faults committed in the course of their practice.

A professional engineer is in private practice if they provide, to a client other than their employer or firm, professional services corresponding to professional activities reserved for engineers (under sections 2 and 3 of the Engineers Act).

Members are in private practice if they:

- work for a consulting engineering firm
- provide professional engineering services to external clients (e.g., self-employed consultants, building and other inspectors, members who work in an analytical laboratory, a university employee providing services to university clients, or any other expert who provides advice on a professional activity reserved for engineers).

If you are engaged in professional activities reserved for private practice, you are required to enroll in the group professional liability insurance plan issued by the OIQ's exclusive broker, at the very least for the work performed on the project for which you are requesting a temporary permit. You must provide the OIQ with information regarding your liability insurance coverage.

An exemption may be granted in certain circumstances, see sections 5 and 6 of the [Regulation](#) – in French.
